A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LAMESA, TEXAS, AUTHORIZING THE CITY TO COLLECT FEES CHARGED BY THIRD PARTIES FOR PERMITS, BUIDING INSPECTIONS AND PLAN REVIEW IN ADDITION TO THE FEES CHARGED BY THE CITY OF LAMESA FOR SUCH PERMITS, BUILDING INSPECTIONS AND PLAN REVIEWS.

WHEREAS, due to the City of Lamesa not having a building inspector currently employed by the City, the City must contract with area city building inspectors and private inspection companies to issue permits and perform required inspections and plan reviews; and

WHEREAS, additional expenses are incurred by the City for mileage and fees charged by such third parties in connection with the issuance of permits and performance of such inspections and plan reviews and the City desires to pass these additional charges and expenses to the person or entity applying for such permits, building inspections and plan reviews.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF LAMESA, TEXAS:

That the City of Lamesa be, and is hereby, authorized to collect any and all fees and expenses charged by any third party for issuing permits and conducting building inspections and plan reviews within the City of Lamesa in addition to the fees charged by the City of Lamesa for all permits, building inspections and plan reviews required by the ordinances of the City of Lamesa.

PLUMBING INSPECTOR EXAMINATION - IMPORTANT INFORMATION

Minimum qualification requirements for Plumber Inspector examination:

- Must meet one of the following eligibility requirements:
- Be currently licensed as a Master or Journeyman Plumber in the state of Texas
- Hold a Master or Journeyman Plumber license in another state and pass the Texas State Board of Plumbing Examiners' Journeyman Plumber examination
- Hold a Plumbing Inspector license in another state that has licensing requirements substantially equivalent to the licensing requirements of the Texas State Board of Plumbing Examiners
- Be a professional engineer or professional architect licensed in the state of Texas; or
- Be able to verify a total of 500 hours training or experience in the plumbing industry, which shall be credited by a combination of the following:
 - 100 hours credit for successful completion of a plumbing related certification issued by the International Association of Plumbing and Mechanical Officials (IAPMO) or the International Code Council (ICC).
 - 100 hours credit for successful completion of a Board approved Medical Gas Piping Installation Endorsement Training Program.
 - 100 hours credit for successful completion of a Board approved Water Supply Protection Specialist Endorsement Training program.
 - o 100 hours credit for successful completion of an approved Backflow Tester Certification Program.
 - o 6 hours credit for successful completion of each different Board approved Continuing Professional Education for License Plumbers and Plumbing Inspectors course.
 - Actual hours, with a maximum of 100 hours, credit for approved, documented and verified plumbing related training academy or educational sessions.
 - Actual hours, with a maximum of 200 hours, credit for on the job work experience in the plumbing trade or approved similar plumbing related trade, as verified by former employers.
 - Actual hours, with a maximum of 200 hours, credit for documented and verified on the job training in the enforcement of plumbing codes under the direct supervision of a licensed Plumbing Inspector
- Must have a high school diploma or General Equivalency Diploma (GED). A copy of the diploma or GED must be submitted with the application.
- Must have proof that the applicant is a citizen or national of the United States, or an alien lawfully admitted to
 the United States for permanent residence, or an alien authorized to work lawfully in the United States. Proof
 must be provided with application.
- Must submit a legible copy of current photographic identification issued by the State of Texas or another state
 or jurisdiction.
- Must submit Plumbing Inspector Examination application and fee (\$55).

An overview of the Plumbing Inspector examination, an explanation of how to prepare for the examination and sample questions are provided in detail in the:

- Plumbing Inspector Examination Review Course and may be downloaded free of charge at www.tsbpe.texas.gov under "Applications and Forms".

Your Identity Will be Verified:

Photographic identification, such as a drivers license or state issued identification, will be required from the applicant on the day of the examination and will be verified before an examination may be given to the applicant.

<u>Training Periods for Examination Failures</u>: Board Rule Sec. 363.9 requires the following training periods for any examination failure (all or part): (1) First failure: a 30-day training period, (2) Second failure: a 60-day training period, (3) Third and subsequent failures: a 90-day training period.

<u>Americans with Disabilities Act</u>: The TSBPE offers reasonable accommodations for persons taking the examination, as required by the Americans With Disabilities Act. If you require special accommodations, please make such request in writing and submit with your application for examination.
