Service shall continue and the undersigned shall be responsible for all charges until the undersigned gives no writing at the office of the City Utility Billing Department to discontinue service.

It is understood that if I/we shall at any time fail to pay when due any charges for service or repairs, the city may discontinue such service absolutely without notice until applicable service charges as prescribed by the code of ordinances, are paid. No consumer shall supply water to other persons or families except for use on the premises with written permission of the City of Lamesa. I/we will abide by and consider part of this contract whatever ordinances, rules and regulations the City Council may adopt concerning operation of the water system and utility service provided by the City of Lamesa.
